Terms & Conditions

1. This offer is only applicable to the existing employees or members of corporations and associations (each an **"Organization"**) designated by Hongkong International Theme Parks Limited (**"HKITP"**) for this offer (**"Eligible Guests"**).
2. This offer is only applicable to purchase of new Magic Access memberships of any types (**"Magic Access"**) at the Ticket Booths (**"Ticket Booth"**) in the Main Entrance and Magic Access Service Station (**"Service Station"**) of the Hong Kong Disneyland Park (**"Park"**) at such price as determined by HKITP from time to time from July 24, 2026 to September 30, 2026 (**"Promotion Period"**) by Eligible Guests.
3. The offer is not available at online or other sales channels or location other than Ticket Booth and Service Station.
4. Subject to these terms and conditions and availability, each Eligible Guest may purchase up to ten (10) Magic Access memberships per transaction during Promotion Period. Discounted Magic Access may only be used by Eligible Guests and his/her family members or friends only.
5. For the purposes of these terms and conditions, any Magic Access membership purchased under this offer shall be referred to as **"Discounted Magic Access"** and the price of Magic Access as published on the Hong Kong Disneyland website www.hongkongdisneyland.com (the **"Website"**) shall be known as the **"Published Price"**. The Discounted Magic Access prices may subject to change based on the Published Price as determined by HKITP in its sole discretion without advance or further notice.
6. Each Eligible Guest warrants that he/she has read these terms and conditions carefully. Each Eligible Guest signifies his/her complete acceptance and full understanding of these terms and conditions by participating in this offer. In the event of any dispute regarding these Terms and Conditions, conduct, results and all other matters relating to this offer, the decision of HKITP shall be final.
7. To participate in this offer, each Eligible Guest is required to (i) present his/her valid staff ID card, business card, company letter, membership card or other identification or authorization documents issued by the Eligible Guests' Organization, (ii) present such personal identification* and (iii) provide such personal data as HKITP may require at the time of purchase, (iv) have his/her photograph taken, and (v) follow such procedures stipulated by HKITP. HKITP may refuse admission to the Park if in HKITP's determination the identity of the Eligible Guest cannot be verified by HKITP. If the Eligible Guest prefers not to have his/her photo retained by HKITP after it is taken, he/she may, before card issue, ask a cast member about alternative verification arrangement as HKITP may provide from time to time[#].

* The photo identification must be valid and bear the full name and a recent photo of the Eligible Guest.

Types of acceptable photo identification may include:

(a) for General or Senior membership:

- (i) Hong Kong residents: Hong Kong identity card or passport;
- (ii) Non-Hong Kong residents: government-issued photo identification (such as passport, driver's license or PRC resident identity card).

(b) for Child membership: photo identification issued by a government or registered school (such as passport, Exit-Entry Permit, school handbook with official school stamp or student card).

(c) for Student membership: photo identification issued by a registered school (such as school handbook with official school stamps or student card) showing the guest's full-time student registration.

Example of alternative verification arrangement may include presenting such photo identification and provide such personal information as HKITP may require of the relevant guest(s) to our Cast Members upon card issue and each entry to the Park.

8. Discounted Magic Access must be used in accordance with these terms and conditions and the Magic Access Terms and Conditions available at www.hongkongdisneyland.com/magic-access-members/. Discounted Magic Access not used in accordance with these terms and conditions and/or the Magic Access Terms and Conditions will be void without compensation, exchange and/or refund.
9. All guests are required to have a valid reservation with valid tickets or membership cards before visiting the Park. Park visit reservation of each type of ticket or membership card is subject to a limited quota. Reservation will not be accepted once the respective quota is full.
